Low Water Rates and Mandatory Water Conservation

Great Oaks' rates for water service continue to be the lowest in San José by an even wider margin than in past years – even with the Mandatory Water Conservation restrictions required by the State Water Resources Control Board and the California Public Utilities Commission.

Santa Clara Valley Water District Litigation Update

In November 2005, Great Oaks Water filed a lawsuit against the Santa Clara Valley Water District (SCVWD) for failing to properly set Groundwater Charges, also known as Pump Tax. In 2009, Great Oaks prevailed in both of two portions of the case in the trial court. In February 2010, the SCVWD appealed the decision and in December 2015, the court of appeal issued a decision that reversed the trial court judgment and ordered Great Oaks and SCVWD back to the trial court for further proceedings. Neither Great Oaks nor SCVWD were satisfied with the court of appeal decision and both petitioned the California Supreme Court to review the case. The Supreme Court granted review, but delayed briefing until it decides a related case. In the meantime, Great Oaks continues to challenge SCVWD's ever-increasing pump taxes, which now account for about 50% of your water bill.

In these cases, the most recent sample data are included, along with the year in which the sample was taken.

Source Water Assessment

Great Oaks Water conducted Drinking Water Source Assessments for all wells to determine potential sources of contamination. Assessments were performed in accordance with the Safe Drinking Water Act requirements. The assessments indicate that the wells may be vulnerable to contaminants from the following sources: septic systems, sewer collection systems serving nearby single family residential housing, nearby agricultural wells, gas stations, parks, highways and their related activities, nearby computer-related manufacturing facilities, roads, streets, parking lots, railroads, spreading basins, storm-drain discharge, crops, illegal activities, unauthorized dumping, unregulated tanks, photo processing and printing, and monitoring wells. All of Great Oaks Water Company's wells are constructed to minimize the influence of these potential contaminants under the approval of the California Department of Public Health. Nitrate

Nitrate in drinking water at levels above 10mg/l (as N) is a health risk for infants of less than six months of age. Such nitrate levels in drinking water can interfere with the capacity of the infant's blood to carry oxygen, resulting in a serious illness; symptoms include shortness of breath and blueness of the skin. Nitrate levels above 10mg/l (as N) may also affect the ability of the blood to carry oxygen in other individuals, such as pregnant women and those with certain specific enzyme deficiencies. If you are caring for an infant, or you are pregnant, you should ask advice from your health care provider. Nitrate levels in Great Oaks Water Company's water sources are shown in the enclosed table. In 2014 Great Oaks Water Company did not detect nitrate at or above 10mg/l (as N) in any sources.

Lead

Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. We are responsible for providing high-quality drinking water, but cannot control the variety of materials used in plumbing components.

If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap for 30 seconds to 2 minutes before using water for drinking or cooking. If you are concerned about lead levels in your water, you may wish to have your water tested. Source Water Description

The customers of Great Oaks Water Company are fortunate to have water supplied from very pristine aquifers underlying this valley. All of our water is pumped from 20 wells (not surface water) located throughout our service area.

Well Protection Plan

Great Oaks Water ensures the safe operation and restricts access to all of the wells in our system. It is every resident's responsibility to guard against any activity that could do harm or contaminate our source water. All of the land in Great Oaks Waters service area is a channel to the water our wells draw. Be aware that oil spills and chemical spills can wash off the surface and make their way to storm drains and ultimately into the ground. Address these situations immediately to minimize their impact on our precious resource. Great Oaks Water will continue to do its part to protect our well sites, now all of us need to do our part to protect the watershed.

About Our Violation

In December 2016, Great Oaks Water Company was issued a Notice of Violation from the State Water Resources Control Board Division of Drinking Water for exceeding the MCL for monthly bacteriological sampling.

33 out of 212 samples taken during the month of December 2016 indicated the presence of coliform bacteria. Great Oaks Water Company immediately isolated a new section of water main as soon as we received word of the contamination and did emergency chlorination throughout the entire system to eliminate the bacteria. After one week with all water sampling being free of coliform bacteria, Great Oaks Water Company stopped emergency chlorination of the water system. Since December 2016 Great Oaks Water Company has been in full compliance with all drinking water standards. The new section of water main is isolated from the water system and will remain so until Great Oaks Water Company can properly clean and disinfect the pipeline. Great Oaks Water Company will conduct several rounds of bacteriological testing resulting in negative total coliform and negative Ecoli. Great Oaks Water Company must receive permission from the State Water Resources Control Board Division of Drinking Water before returning the new pipeline to service.

Coliforms are bacteria that are naturally present in the environment and are used as an indicator that other potentially harmful waterborne pathogens may be present or that a potential pathway exists through which contamination may enter the drinking water distribution system. We found coliforms indicating the need to look for potential problems in distribution. When this occurs, we are required to conduct assessments to identify and to correct any problems that were found during these assessments.

During the past year (2016) Great Oaks Water Company was required to conduct one Level 1 Assessment We completed one Level 1 Assessment. In addition we were required to take one Corrective Action and we completed one Corrective Action. The Assessment identified the new pipeline as the source of contamination and Great Oaks Water Company took all necessary steps to eliminate that contamination. In the future Great Oaks Water Company will closely monitor with repetitive bacteriological sampling any new pipeline in our service area before the pipeline is put into service. Great Oaks Water Company will receive permission from the State Water Resources Control Board Division of Drinking Water prior to putting any new pipeline in service.

Substances That Could Be In Water

The sources of drinking water (both tap water and bottled water) include rivers, lakes, streams, ponds, reservoirs, springs, and wells. As water travels over the surface of the land or through the ground, it dissolves naturally occurring minerals and, in some cases, radioactive material, and can pick up substances resulting from the presence of animals or from human activity. In order to ensure that tap water is safe to drink, the U.S. Environmental Protection Agency (U.S. EPA) and the State Department of Public Health (Department) prescribe regulations that limit the amount of certain contaminants in water provided by public water systems. Department regulations also establish limits for contaminants in bottled water that must provide the same protection for public health. Drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that water poses a health risk. Contaminants that may be present in source water include:

- ◆ Microbial Contaminants, such as viruses and bacteria, that may come from sewage treatment plants, septic systems, agricultural livestock operations, and wildlife;
- ◆ Inorganic Contaminants, such as salts and metals, that can be naturally occurring or can result from urban storm water runoff, industrial or domestic wastewater discharges, oil and gas production, mining, or farming;
- ◆ Pesticides and Herbicides, that may come from a variety of sources, such as agriculture, urban storm water runoff, and residential uses;
- ◆ Organic Chemical Contaminants, including synthetic and volatile organic chemicals, which are by-products of industrial processes and petroleum production and which can also come from gas stations, urban storm water runoff, agricultural applications, and septic systems;
- ◆ Radioactive Contaminants, that can be naturally occurring or can be the result of oil and gas production and mining activities.
