Advice Letter 330-W Great Oaks Water Company (U-162-W) to the California Public Utilities Commission Requesting Authorization to Increase Revenue to Offset Increased Pump Tax

Great Oaks Water Company (Great Oaks) transmits this Tier 1 advice letter establishing a change in base rates to offset increased pump taxes being imposed upon Great Oaks by the Santa Clara Valley Water District effective July 1, 2025. Summary of Advice Letter 330-W

Great Oaks filed Advice Letter 330-W on May 29, 2025 to increase revenue to address higher groundwater production charges (pump taxes) levied by the Santa Clara Valley Water District (Valley Water), effective July 1, 2025. On May 27, 2025, the Valley Water Board of Directors approved Staff recommended rates with no changes for the period of time from July 1, 2025 to June 30, 2026. A copy of the Valley Water Resolution is attached hereto as Exhibit A.

The Water Division of the California Public Utilities Commission (Commission) has requested that instead of recovering increased costs due to the higher pump taxes levied by Valley Water through a surcharge, Great Oaks should request the additional cost recovery through a change in base rates. This Advice Letter 330-W complies with the Water Division's request.

The increase in groundwater charges is included in the rates that will be established by the Commission's Decision in A.24-07-001. However, because the final decision has not yet been issued, it is uncertain whether Great Oaks will have sufficient time to implement the new rates by July 1, 2025. The increase in the groundwater charges is substantial and must be reflected in rates effective July 1, 2025 to better enable Great Oaks to cover the higher groundwater charges and to minimize any surcharges needed to recover the difference between the new and the prior groundwater charges levied by Valley Water, pending the final rates approved by the Commission for A.24-07-001.

The amount of groundwater charges included in Advice Letter 325-W-A's rate calculations was \$15,045,337. With the recent increase in groundwater charges, the total amount of groundwater charges projected for the 2025/2026 rate year has increased by \$1,531,928.¹

The increase in groundwater charges also results in increases in Account 775 Uncollectible Expenses (increase of \$3,007, from \$51,229 to \$54,235) and in Account 796 Franchise Requirements (increase of 31,325, from 535,606 to \$566,931). The total increase in the revenue requirement resulting from the increase in groundwater charges is \$1,566,260, from \$26,780,279 to

\$28,346,539. This represents an increase in the revenue requirement of 5.8% over the revenue requirement from the previous Advice Letter 328-W.

Effects on Average Customer Bills

The effect of the new and higher pump tax on the bill of an average single-family residential customer with a 3/4" x 3/4" meter using 10 CCF of water per month is \$7.81 (5.84%) per bimonthly bill, as shown in the following table taken from the Exhibit B Workpapers, page WP-3.

Effective Date – July 1, 2025

The base rates established through this Advice Letter become effective July 1, 2025.

Tier Designation

This is a Tier 1 Advice Letter pursuant to General Order 96-B and Water Industry Rule 7.3.1(7).

Notice and Service

A Public Notice addressing the rate changes was published as a legal notice in the form attached hereto as Exhibit C in the San Jose Mercury News, a newspaper of local circulation, pursuant to General Order 96-B, Water Industry Rule 3.1. Proof of publication is attached hereto A copy of this Advice Letter is also being served upon the Distribution List provided below.

Protests and Responses

Anyone may protest and respond to this Advice Letter. A Response supports the filing and may contain information that proves useful to the Commission in evaluating the Advice Letter. A Protest objects to the Advice Letter in whole or in part and must set forth specific grounds on which it is based. These grounds may be based upon the following:

- (1) The utility did not properly serve or give notice of the Advice Letter; or
- (2) The relief requested in the Advice Letter would violate a statute or Commission order, or is not authorized by statute or Commission order on which the utility relies; or
- (3) The analysis, calculations, or data in the Advice Letter contain material error or omissions; or
- (4) The relief requested in the Advice Letter is pending before the Commission in a formal proceeding; or
- (5) The relief requested in the Advice Letter requires consideration in a formal hearing, or is otherwise inappropriate for the Advice Letter process; or
- (6) The relief requested in the Advice Letter is unjust, unreasonable, or discriminatory (provided that such a Protest may not be made where it would require re-litigating a prior order of the Commission).

Any Protest or Response must be made in writing or by electronic mail and must be received by the Water Division of the Commission within 20 days of the date this Advice Letter is filed. The Advice Letter process does not provide for any Protests, Responses or other comments, except for a reply by Great Oaks, after the 20-day comment period expires. SPECIAL CONDITIONS

- 1. The Santa Clara Valley Water District requires the customer to certify the water is used to irrigate commercial agricultural crops for sale to qualify for this rate. It is an express condition of this Irrigation Service that the customer cooperates in making the necessary certification to the Water District.
- 2. The Santa Clara Valley Water District has surcharges or discounts applicable to water used to irrigate commercial agricultural crops if the customer/farmer participates in the Water District's special programs. These surcharges or discounts are applied per Acre Ft., are granted or imposed by the Water District each month based on the customer/farmer's level of participation, and will be passed through by the Company each month to the customer/farmer.
- 3. All bills are subject to the reimbursement fee set forth in Schedule No. UF.
- 4. To provide funding for the Utility's Customer Assistance Program (CAP), as described in Tariff Rule 22, a surcharge of \$0.1370 will be added to the Quantity Charge for all water sold to non-CAP participants on and after January 7, 2025.
- 5. Customers who receive water deliveries for agricultural purposes under this schedule, and who present evidence to the Utility that such deliveries qualify for the lower pump tax rates levied by the Santa Clara Valley Water District for agricultural water, shall receive a credit of \$4.1434 per 100 (R) cu.ft. used during the period covered by that bill on and after July 1, 2025.
- 6. To refund a net over-collection in authorized balancing and memorandum accounts, a credit in the total amount of \$156.56 will be applied to the service charge portion of each customer's bill over a period of twenty-two months after the effective date of Advice Letter 326-W-A, January 1, 2025. The amount of the credit per two-months billing cycle will be \$14.23 over eleven billing cycles. The amount of the credit per one-month billing cycle will be \$7.12 over twenty-two billing cycles. Only customers with accounts established by December 31, 2023, will receive the credit against the service charge.

RESOLUTION NO. 2025-

DETERMINING GROUNDWATER PRODUCTION CHARGES FOR FISCAL YEAR 2025–2026

WHEREAS, the Board of Directors of the Santa Clara Valley Water District (Valley Water) does find and declare as follows:

- 1. That pursuant to Section 26.5 of the Santa Clara Valley Water District Act ("District Act"), a written report detailing Valley Water's activities in the protection and augmentation of the water supplies of Valley Water has been prepared including: a financial analysis of Valley Water's water utility system, information as to the present and future water requirements of Valley Water, the water supply available to Valley Water, and future capital improvements and maintenance and operating requirements; a method of financing such requirements; a recommendation as to whether or not the groundwater production charge should continue to be levied in any zone or zones of Valley Water during the ensuing fiscal year; and a proposal of a rate per acre-foot for agricultural water and a rate per acre-foot for all water other than agricultural water for Zones W-2, W-5, W-7, and W-8;
- 2. That on the 28th day of February 2025, said report was duly delivered to the Clerk of the Valley Water Board;
- 3. That the Clerk, pursuant to Section 26.6 of the District Act, gave due notice of the receipt of the report and of a public hearing to be held commencing on the 8th day of April 2025, by teleconference, videoconference, or both and in-person attendance at the time stated;
- 4. That on February 28, 2025, written notice was mailed to all owners and operators of water-producing facilities within Valley Water's boundaries, advising of the proposed groundwater production charge rates to be levied, and of the opportunities to be heard concerning such charges;
- 5. That pursuant to Section 26.6 of the District Act, on the 8th day of April 2025, at 1 p.m. a public hearing upon said report was duly commenced, and was continued for further hearing to the evening of April 25, 2025, in Morgan Hill, California, and continued again to the afternoon of May 16, 2025, whereupon the hearing was concluded, more than 45 days after notice of the hearing was given;
- 6. That during said public hearing, additional information and evidence was provided that was considered by the Board in making its decision on groundwater production charges, and the public and all persons subject to groundwater production charges were invited to speak or present written comments at the public hearing;
- 7. That the charges established by this resolution are for the purpose of paying the cost of constructing, maintaining, and operating facilities to import water into Valley Water; paying the cost of purchasing imported water; paying the cost of constructing, maintaining, and operating facilities for groundwater recharge, surface distribution, and the purification and treatment of water; and paying the principal and interest of any bonded indebtedness or other financial obligations of Valley Water incurred for those purposes;

- 8. That this Board considered all comments objecting to the proposed groundwater production charge increases for Zones W-2, W-5, W-7, and W-8;
- 9. That this Board, based on the whole record before it, finds that the revenues derived from the groundwater production charges will not exceed the funds required to provide services to Zones W-2, W-5, W-7, and W-8, as authorized under the District Act, and that the amount levied does not and will not exceed the proportional cost of service; and
- 10. That the California Environmental Quality Act does not apply to approval of these charges.

NOW, THEREFORE BE IT RESOLVED by the Board of Directors of the Santa Clara Valley Water District as follows:

FIRST: Valley Water activities in the geographic area identified as Zone W-2 benefit said zone and those who rely directly or indirectly upon the groundwater supplies of such zone and water imported into such zone; Valley Water activities in the geographic area of Valley Water identified as Zone W-5 benefit said zone and those who rely directly or indirectly upon the groundwater supplies of such zone and water imported into such zone: Valley Water activities in the geographic area of Valley Water identified as Zone W-7 benefit said zone and those who rely directly or indirectly upon the groundwater supplies of such zone and water imported into such zone; and Valley Water activities in the geographic area of Valley Water identified as Zone W-8 benefit said zone and those who rely directly or indirectly upon the groundwater supplies of such zone and water imported into such zone. Revenues derived from groundwater production charges shall be used only for such activities as authorized under the District Act.

SECOND: Based upon the findings and determinations from said hearing, the entire record presented to the Board and results of protests received, the Board hereby determines that fiscal year 2025–2026 groundwater production charge (per acre-foot) for agricultural water and for all water other than agricultural water should be increased. Accordingly, such charges shall be, and are hereby set as follows on all persons operating groundwater-producing facilities in Zone W-2 of Valley Water for fiscal year 2025–2026 (July 1, 2025–June 30, 2026) at the following per acre-foot rates:



GREAT OAKS WATER COMPANY NOTICE OF ESCALATION YEAR RATE CHANGES AUTHORIZED BY CALIFORNIA PUBLIC UTILITIES COMMISSION

Great Oaks Water Company (Great Oaks) has filed Advice Letter 330-W (AL 330-W) with the California Public Utilities Commission (Commission) requesting authorization to address higher groundwater charges (pump taxes) recently adopted by the Santa Clara Valley Water District. Current rates will apply to water sold through June 30, 2025 and will then be replaced by the new AL 330-W rates. The AL 330-W rates will increase Great Oaks' total revenue requirement by \$1,566,260 (5.85%), from \$26,780,279 to \$28,346,539. As shown in the table below, the average single-family residential customer bill will increase by \$7.81 (5.84%). Complete copies of the AL filings are available at www.greatoakswater.com.

<u>Protests and Responses</u>: Anyone may protest and respond to this Advice Letter. A Response supports the filing and may contain information that proves useful to the Commission in evaluating the Advice Letters. A Protest objects to the Advice Letter in whole or in part and must set forth specific grounds on which it is based. These grounds may be based upon the following:

- (1) The utility did not properly serve or give notice of the Advice Letters; or
- (2) The relief requested in the Advice Letters would violate a statute or Commission order, or is not authorized by statute or Commission order on which the utility relies; or
- (3) The analysis, calculations, or data in the Advice Letters contain material error or omissions; or
- (4) The relief requested in the Advice Letters is pending before the Commission in a formal proceeding; or
- (5) The relief requested in the Advice Letters requires consideration in a formal hearing, or is otherwise inappropriate for the Advice Letter process; or
- (6) The relief requested in the Advice Letters is unjust, unreasonable, or discriminatory (provided that such a Protest may not be made where it would require re-litigating a prior order of the Commission).

Any Protest or Response must be made in writing or by electronic mail and must be received by the Water Division of the Commission within 20 days of the date this Advice Letters are filed. The Advice Letter process does not provide for any Protests, Responses or other comments, except for a reply by Great Oaks Water Company, after the 20-day comment period expires.
